The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons and Jerry J. Tlach present. Absent: none.

The minutes of August 8, 2022 meeting were read and approved.

A public hearing was held on the sale of county land and final determination in section 34, Twin Lake Township. Those present for the hearing were Supervisors Greiman, Rayhons, and Tlach, Auditor Michelle K. Eisenman and County Engineer Jeremy Purvis. Certification that publication as to the date and time and place of the hearing was on file in the Auditor's Office. There were no other comments received, no objections received. On motion by Supervisor Rayhons to close the public hearing, seconded by Supervisor Greiman. All ayes.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following Resolution:

WHEREAS, it was proposed that Hancock County offer for sale property as described in Resolution 2022-043 to Ryan Walk, to be conveyed by Quit Claim Deed;

WHEREAS, Hancock County, in compliance with the requirements set for in Iowa Code section 331.361, held a public hearing on the proposal for final determination on this day;

WHEREAS, notice for said public hearing was published as required by Iowa Code section 331.361, and;

WHEREAS, the proposal for final determination is that Hancock County would sell the property, commonly referred to as Katuin Pit for the amount of \$62,177, having the following legal description:
