The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Osmund (Bud) Jermeland present. Absent: none.

On motion by Supervisor Rayhons, seconded by Greiman and carried unanimously, the Board approved the tentative agenda. On motion by Supervisor Greiman, seconded by Supervisor Rayhons and carried, the Board approved the minutes of March 30, 2026.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Hiring of Paul Schroader, summer help in Secondary Roads, effective April 20, 2026 at \$27.00 per hour, Levi Brandt, summer help in Secondary Roads, effective May 18, 2026, at \$18.00 per hour, and Jack Hackman, summer help in Secondary Roads, effective May 26, 2026, at \$18.00 per hour. Hancock County Secondary Road's Iowa Department of Transportation budget for Fiscal Year 2026-2027. Signed a five year safety test agreement with Schumacher Elevator for elevator testing and inspections. Certification of the costs of the Special Election for the City of Forest City held on March 17, 2026 in the amount of \$2,711.55. Class C retail alcohol license with outdoor service for Hillside Golf & Dining, LLC. Signed letter for opting out of CSN program through Iowa State Association of Counties for mental health advocate. Send abatement notices to the following properties: 2822 Otto Ave and 2839 Orr Ave after receiving the public health official's report on these properties. Send reminder letters to the following properties: 2349 Navy Ave, 1430 234th Street, and 1446 234th Street to continue clean up on the abatement notice.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: Hancock County Secondary Road's Iowa Department of Transportation 5-year construction program for Fiscal Years 2027-2031. Set April 24, 2026 at 3:00 p.m. as the date and time for request for proposals for audit services due to the Auditor's office with the opening of said proposals and consideration for award of said proposals for audit services for April 27, 2026 at 9:30 a.m. Quarterly reports of the Hancock County Auditor, Recorder, and Sheriff for period ending March 31, 2026.
