The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of January 2, 2020 meeting were read and approved.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach, and carried unanimously, the Board gave approval to the following: Reviewed and accepted Second Judicial District Annual Report for Fiscal Year ending June 30, 2019. Quarterly report of the Hancock County Auditor for period ending December 31, 2019. Approved the plans and specifications for Drainage District no. 3 and 4 Lateral 10 Tile Facility Improvement and set the date and time for opening of bids for Drainage District no. 3 and 4 Lateral 10 Tile Facility Improvement for January 23, 2020 at 10:00 a.m. and set the date and time for consideration of bids for award for Drainage District no. 3 and 4 Lateral 10 Tile Facility Improvements for January 27, 2020 at 9:30 a.m. with the option of no more than 20 installment payments at a 5 percent interest rate. Signed agreement for County Bridge Federal-Aid SWAP funding for project BROS-SWAP-C041(127)--SE-41. Approved the final plans for L-1224--73-41 culvert replacement-twin box on 130<sup>th</sup> Street over middle branch of Boone River/Drainage District no. 8 on the north line of section 24, Magor Township.

Agreement for assignment of Hancock County tax sale certificate number 2720 to Michael or Kristi Hejlik for the sum of \$996.53 for the tax sale certificate assignment, \$10.00 for assignment fee and \$503.00 for subsequent delinquent taxes on real estate tax parcel 0601 0623200000. Approved the final plans for BROS-SWAP-C041(127)--SE-41 bridge replacement on 110<sup>th</sup> Street over branch Boone River from Grant Avenue to Hill Avenue at Northwest, section 31, Amsterdam Township.
