The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons and Jerry J. Tlach present. Absent: none.

The minutes of April 22, 2019 and April 23, 2019 meetings were read and approved.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons, and carried, the Board gave approval to the following: Hiring of David Cook, summer help in the Secondary Roads Department, effective May 13, 2019 at \$10.50 per hour, hiring of Seth Weiland, summer help in the Secondary Roads Department, effective May 13, 2019 at \$11.00 per hour, hiring of Jerry Weiskamp, summer help in the Secondary Roads Department, effective May 20, 2019 at \$14.00 per hour, hiring of Reece Smith, summer help in the Secondary Roads Department, effective May 29, 2019 at \$10.00 per hour, and hiring of Lucas Weiland, summer help in the Secondary Roads Department, effective May 29, 2019 at \$10.00 per hour. Certification of cost allocation plan as submitted by Cost Advisory Services and based on fiscal year ending June 30, 2018 and to establish cost allocation of billings for use in Fiscal Year 2020. Signed contract for Drainage District no. 7 Branch 60 Open Ditch with Reutzler Excavating, Inc., Burt, Iowa in the amount of \$22,569.80. Approved the list of items in the County's possession to be sold as presented and have Hefty Auction Service, Kanawha, Iowa, review the items to be sold and proceed to an auction for sale of items.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Accepted the best and highest of two bids received for county owned property (Secondary Road ground) as follows: 37.7 acres, section 27, Orthel Township, (Hutchins Pit) at \$191.75 per acre to Tucker Barickman, Garner. Signed Assignment Agreement for Austin Farm Pit in the East Half (E ½) of the Northeast Quarter (NE ¼), section 11, Crystal Township with Joseph Leerar as Assignor and Brad Sorenson as Assignee with the rent amount to be paid modified to \$ 8,396.80 to reflect the correction to acreage due to building site acres removed. Signed contract for Drainage District no. 3 and 4 Lateral 2 Open Ditch and Lateral 51 Tile Improvements in the amount of \$232,825.40.

No further business to come before the Board, motion made to adjourn at 12:02 p.m. by Supervisor Greiman and carried. All Supervisors present voting, "Aye," session to adjourn and will meet again on May 6, 2019.
