The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of August 26, 2019 meeting were read and approved.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: Payroll change for Jennifer Colby, Communications department, from \$15.00 to \$15.75 effective January 26, 2019 for completion of jail certification. Signed Proclamation for September 2019 as National Voter Registration Month and September 24, 2019 as National Voter Registration Day. Approved the issuance of six improvement certificate numbers 461, 462, 463, 464, 465, 466 for Leland Hummel Revocable Trust and Beulah A. Hummel Revocable Trust for Drainage District no. 9 Main Open Ditch. Signed letter of support for Hancock County Historical Society for Aureon Grant.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Appointed Jim Nelson, Britt to the Hancock County Veteran Affairs Commission for the remainder of the term ending June 30, 2020. Approved the issuance of four improvement certificate numbers 457, 458, 459, 460, for Jean A. Baack Revocable Trust for Drainage District no. 9 Main Open Ditch.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman, and carried unanimously, the Board gave approval to the following resolution:

RESOLUTION No. 2019-034
Removal of Bridge Postings

WHEREAS: The Board of Supervisors is empowered under authority of Sections 321.236 Sub. (8), 321.255 and 321.471 to 321.473 to prohibit the operation of vehicles or impose limitations as to the weight thereof on designated highways or highway structures under their jurisdiction, and

WHEREAS: The Hancock County Engineer has caused to be completed the Structure Inventory and Appraisal of certain Hancock County bridges in accordance with the National Bridge Inspection Standards and it has been determined that an adjustment to the bridge's load restrictions have been updated and is no longer required to be posted.

NOW, THEREFORE, BE IT RESOLVED by the Hancock County Board of Supervisors that:

FHWA No. 173550 (Local Bridge #4408) on 210th Street over Drainage Ditch No. 10 in Section 9, T-95N, R-26W, Boone Township and is posted as legal.

FHWA No. 173990 (Local Bridge #6022) on 250th Street over Drainage Ditch No. 156 in Section 24, T-96N, R-26W, Orthel Township and is posted as legal.

FHWA No. 174280 (Local Bridge #9428) on Hill Ave. over Drainage Ditch No. 37 in Section 5, T-97N, R-25W, Crystal Township and is posted as legal.

BE IT RESOLVED by the Hancock County Board of Supervisors that:

Resolution Removal of Bridge Posting be amended to reflect above changes in Bridge Weight Limit Posting signed on June 10, 2019.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons, and carried, the Board authorized the County Auditor to issue checks for the claims on file this date, September 3, 2019. A full listing of all claims paid in September, 2019 will be published in September 16, 2019 minutes.
