The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of January 13, 2020 meeting were read and approved.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons, and carried unanimously, the Board gave approval to the following: Reviewed and accepted the 2018-2019 independent auditor's report from Renner & Birchem, PC. Set February 3, 2020 at 9:15 a.m. as the date and time for a public hearing for one new deep pit swine finisher confinement building as an expansion to an existing swine confinement facility in section 8, Liberty Township, Evan Beshey. Approved the Hancock County Policy Regarding Compensation for Damages for Drainage District Projects for 2020. Approved Hancock County Secondary Road Right-of-Way Acquisition Policy for 2020. County Treasurer's semi-annual report for the period of July 1, 2019 to December 31, 2019.
