**Removal of Bridge Postings**

**WHEREAS:** The Board of Supervisors is empowered under authority of Sections 321.236 Sub. (8), 321.255 and 321.471 to 321.473 to prohibit the operation of vehicles or impose limitations as to the weight thereof on designated highways or highway structures under their jurisdiction, and

**WHEREAS:** The Hancock County Engineer has caused to be completed the Structure Inventory and Appraisal of certain Hancock County bridges in accordance with the National Bridge Inspection Standards and it has been determined that an adjustment to the bridge's load restrictions have been updated and is no longer required to be posted.

FHWA No. 172970 (Local Bridge #1224) on 130<sup>th</sup> Street over Middle Branch Boone River/ Drainage Ditch No. 8 in Section 24, T-94N, R-26W, Magor Township and is posted as legal.

FHWA No. 173280 (Local Bridge #3659) on 190<sup>th</sup> Street over Drainage District No. 6 in Section 21, T-95N, R-24W, Liberty Township and is posted legal.

FHWA No. 173871 (Local Bridge #5071) on 225<sup>th</sup> Street over E. Branch Iowa River in Section 36, T-96N, R-24W, Garfield Township and is posted legal.
