The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman and Gary Rayhons present. Supervisor Jerry J. Tlach arrived at 9:07 a.m. Absent: none.

The minutes of September 14, 2020 meeting were read and approved by Supervisors Rayhons and Tlach. Supervisor Greiman abstained as she was not present at the September 14, 2020 meeting.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: The best and highest bids received for rent for county owned property (Secondary Road ground) as follows: 52.34 acres, section 26, Liberty Township, (Klemme) at \$222 per acre to Grant and Brenda Anderson, Garner; 24.64 acres, section 26, Liberty Township, (Klemme Pasture) at \$1,300 total rent per year (\$52.75 per acre) to Grant and Brenda Anderson, Garner; approximately 15 acres, section 26, Liberty Township, (Klemme hay ground) at \$500 total rent per year (\$33.33 per acre) to Grant and Brenda Anderson, Garner; 52.48 acres, section 11, Crystal Township (Austin Pit) at \$6,100 total rent per year (\$116.23 per acre) to Brad Sorenson, Woden; 5.8 acres, section 14, Garfield Township, (Schlicht Pit) at \$210 per acre to Jerry Zwald, Garner. Signed and approved the lease agreement for County Home Farm in the Southwest Quarter (SW ¼) of the Southwest Quarter (SW ¼) of Section 28 and the Northeast Quarter (NE ¼) of Section 29, Garfield Township with Olson Ag, Inc. Awarded the project for Drainage District no. 57 Main Tile Repair to Holland Contracting Corp., Forest City, Iowa, in the amount of \$197,830.20 as the best and lowest of nine bids noting the publication contained a clerical error in it, continued with awarding of said project per consultation with drainage attorney. Set October 12, 2020 at 9:15 a.m. as the date and time for a public hearing for an amendment to Hancock County's budget for fiscal year 2020-2021.

**RESOLUTION TO GRANT WISCONSIN POWER AND LIGHT COMPANY A
DRAINAGE DISTRICT CROSSING EASEMENT**

RESOLUTION NO. 2020-046

WHEREAS, Wisconsin Power and Light Company desires to locate, maintain, and construct a new fiber optic transmission cable in Hancock County, and

WHEREAS, The proposed components of the transmission cable system that cross the right-of-way of the drainage district open ditch facility, and

WHEREAS, Iowa Code section 468.186 mandates that any person proposing to construct a pipeline, electric transmission line, communication line, underground service line, or similar installation on, over, across or beneath a District right-of-way must, prior to construction, obtain from the governing body of the District an easement to cross the right-of-way, and

WHEREAS, Wisconsin Power and Light Company has filed an Application for Crossing Easements across the drainage district Right-of-Way in Hancock County, and

WHEREAS, The application of Wisconsin Power and Light Company has been approved by the Hancock County Board of Supervisors.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF HANCOCK COUNTY to issue a Crossing Easement to Wisconsin Power and Light Company in accord with the Application on file and subject to Hancock County's Procedures and Conditions for Construction in Drainage District Right-of-Way.
