The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons and Jerry J. Tlach present. Absent: none.

The minutes of February 14, 2022 meeting were read and approved.

Be It Remembered that on this, the 22nd day of February, 2022 at 9:15 a.m. the Board of Supervisors met for the purpose of hearing upon the Hancock County's Proposed Property Tax Levy and Maximum Property Tax Dollars for Fiscal Year 2022-2023. There was a quorum present as required by law. The Board did find the notice of the time and place of hearing had, according to law, been published in the official newspapers of the county, the Summit-Tribune and the Leader, and that the affidavits of said publications were on file with the Auditor and also posted on the County's website, www.hancockcountyiowa.gov. The proposed property tax levy and maximum property tax dollars were taken up and considered and taxpayers could be heard for and against said levies. There were no oral or written comments received. Those present from the public was Angela Nelson-KIOW. Those present via GoToMeeting were Rob Hillesland-Summit-Tribune, Bob Kern, Michelle Eisenman-Auditor, Cale Edwards-Conservation Director and Caller-01(did not identify themselves). Hearing no objections, the Board of Supervisors determined that said proposed property tax levy and maximum property tax dollars be accepted as published. Motion by Supervisor Greiman to close the public hearing, seconded by Supervisor Rayhons. All ayes.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following Resolution:

Resolution No. 2022-014

Approval of FY 2022-2023 Maximum Property Tax Dollars

WHEREAS, the Hancock County Board of Supervisors has considered the proposed FY 2022-2023 county maximum property tax dollars for both General County Services and Rural County Services, and

WHEREAS, a notice concerning the proposed county maximum property tax dollars was published as required and posted on county website, and

WHEREAS, a public hearing concerning the proposed county maximum property tax dollars was held on February 22, 2022.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Hancock County that the maximum property tax dollars for General County Services and Rural County Services for FY 2022-2023 shall not exceed the following:

General County Services - \$4,013,266
Rural County Services - \$1,915,248

The Maximum Property Tax dollars requested in General County Services for FY 2022-2023 does represent an increase of 109.55% from the Maximum Property Tax dollars requested for FY 2021-2022. The Maximum Property Tax dollars requested in Rural County Services for FY 2022-2023 does not represent an increase of 102% from the Maximum Property Tax dollars requested for FY 2021-2022.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: Set March 14, 2022 at 9:15 a.m. as the date and time for the public hearing on Hancock County's Fiscal Year 2022-2023 budget. Class C liquor license with outdoor service and Sunday sales for Slippery Elm Inc. doing business as Slippery Elm Golf Course.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Reviewed and accepted the fiscal year 2020-2021 independent auditor's report from Fort & Schlegel, C.P.A., PC.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board authorized the County Auditor to issue checks for the claims on file from February 7 to February 22, 2022 as follows:
