The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman and Jerry J. Tlach present. Absent: Gary Rayhons.

The minutes of February 22, 2022 meeting were read and approved.

On motion by Supervisor Greiman, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following Resolution:

RESOLUTION 2022-015
FARM TO MARKET REVIEW BOARD APPLICATION

WHEREAS, a county may apply for modifications to its farm to market system to add or subtract mileage from its system, to accept or delete highways gained or lost through jurisdictional transfers, or to change the classification of roads within its system, and

WHEREAS, the Board of Supervisors of HANCOCK County has consulted with its County Engineer and desires to modify its farm to market road system to provide continuity of intra-county and inter-county routes, to meet the needs of existing or potential traffic, to better meet land use needs, or to provide a more suitable location for a farm to market route, and

WHEREAS, application for modifications to any county's farm to market system must be made to the Farm to Market Review Board per the requirements of Code of Iowa Section 306.6,

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF HANCOCK COUNTY that this county is formally requesting that the Farm to Market Review Board approve the following modifications to its farm to market system:

Road segments proposed for addition and removal from the farm to market system:

| 4. Add 210 th Street, from US 69 to Cerro Gordo County line | +6.0 miles, AS to FM |
| 5. Add 200 th Street, from Quincy Ave to Pine Ave | +1.0 mile, AS to FM |
| Add Pine Ave, from 200 th Street to B40 | +1.0 mile, AS to FM |
| 6. Remove Rake Ave, from 200 th Street south 0.5 miles | -0.5 miles, FM to AS |
| 7. Remove R38, from 120 th Street to B55 | -5.0 miles, FM to AS |
| 8. Add 130 th Street, from R18 to Deer Avenue | +2.0 miles, AS to FM |
| Add Deer Avenue, from B63 to 130 th Street | +1.0 mile, AS to FM |

Total: +14.0 miles added, -7.5 miles removed, Net +6.5 miles to Farm-to-Market Road System
