The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons and Jerry J. Tlach present. Absent: None.

The minutes of the November 7, 2022 meeting were read and approved.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Signed 28E Agreement with Iowa Department of Transportation and Hancock County for county issuance.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: Approved the best of two bids received for the East Entrance Vestibule project and Northwest Tower Roof Repair project in the amount of \$645,000 with \$625,000 base bid and \$20,000 Alternate 1 Northwest Tower Roof repair to Dean Snyder Construction, Clear Lake.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following Resolution:

RESOLUTION No. 2022-051
Removal of Bridge Postings

WHEREAS: The Board of Supervisors is empowered under authority of Sections 321.236 Sub. (8), 321.255 and 321.471 to 321.473 to prohibit the operation of vehicles or impose limitations as to the weight thereof on designated highways or highway structures under their jurisdiction, and

WHEREAS: The Hancock County Engineer has caused to be completed the Structure Inventory and Appraisal of certain Hancock County bridges in accordance with the National Bridge Inspection Standards and it has been determined that an adjustment to the bridge's load restrictions have been updated and is no longer required to be posted.

NOW, THEREFORE, BE IT RESOLVED by the Hancock County Board of Supervisors that:

FHWA No. 174071 (Local Bridge #5015) on 225th Street over Drainage Ditch #10 in Section 34, T-95N, R-26W, Orthel Township and is posted as legal.

FHWA No. 173330 (Local Bridge #2053) on 150th Street over E. Branch Iowa River in Section 26, T-95N, R-24W, Liberty Township and is posted as legal.

BE IT RESOLVED by the Hancock County Board of Supervisors that:

Resolution Removal of Bridge Posting be amended to reflect above changes in Bridge Weight Limit Posting signed on May 3, 2021.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons, and carried unanimously, the Board recessed at 11:52 a.m. for lunch and resumed at 2:30 p.m. for the remainder of the meeting for canvassing of the November 8, 2022 General Election results.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Canvass of the results of the General Election held on November 8, 2022.
