The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons and Jerry J. Tlach present. Absent: none.

The minutes of February 13, 2023 meeting were read and approved.

Be It Remembered that on this, the 21st day of February, 2023 at 9:15 a.m. the Board of Supervisors met for the purpose of hearing upon the Hancock County's Proposed Property Tax Levy and Maximum Property Tax Dollars for Fiscal Year 2023-2024. There was a quorum present as required by law. The Board did find the notice of the time and place of hearing had, according to law, been published in the official newspapers of the county, the Summit-Tribune and the Leader, and that the affidavits of said publications were on file with the Auditor and also posted on the County's website, www.hancockcountya.gov. The proposed property tax levy and maximum property tax dollars were taken up and considered and taxpayers could be heard for and against said levies. Discussion was held regarding the maximum property tax dollars and Senate File 181. There were no oral or written comments received. Those present from the public was Angela Nelson-KIOW and Jeremy Purvis-County Engineer. Those present via GoToMeeting were Rob Hillesland-Summit-Tribune, Bob Kern, Cale Edwards-Conservation Director, Marianne Welsh, Assessor and A.J. Taylor-KIOW. Hearing no objections, the Board of Supervisors determined that said proposed property tax levy and maximum property tax dollars be accepted as published. Motion by Supervisor Tlach to close the public hearing, seconded by Supervisor Rayhons. All ayes.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following Resolution:

Resolution No. 2023-005

Approval of FY 2023-2024 Maximum Property Tax Dollars

WHEREAS, the Hancock County Board of Supervisors has considered the proposed FY 2023-2024 county maximum property tax dollars for both General County Services and Rural County Services, and

WHEREAS, a notice concerning the proposed county maximum property tax dollars was published as required and posted on county website, and

WHEREAS, a public hearing concerning the proposed county maximum property tax dollars was held on February 21, 2023.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Hancock County that the maximum property tax dollars for General County Services and Rural County Services for FY 2023-2024 shall not exceed the following:

General County Services - \$4,029,695

Rural County Services - \$2,045,235

The Maximum Property Tax dollars requested in General County Services for FY 2023-2024 does not represent an increase of more than 102% from the Maximum Property Tax dollars requested for FY 2022-2023. The Maximum Property Tax dollars requested in Rural County Services for FY 2023-2024 does represent an increase of 106.79% from the Maximum Property Tax dollars requested for FY 2022-2023.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried unanimously, the Board authorized the County Auditor to issue checks for the claims on file from February 6 to February 21, 2023 as follows:
