The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons and Jerry J. Tlach present. Absent: none.

The minutes of April 10, 2023 meeting were read and approved. The minutes of April 12, 2023 meeting were read and approved by Supervisors Greiman and Tlach. Supervisor Rayhons abstained due to not being present for the meeting.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: Approved pay estimate no. 1 for the East Entrance Vestibule project with Dean Snyder Construction Co. in the amount of \$17,841. Approved an increase in health insurance rates of 6.5% for Fiscal Year 2023-2024 and no change, from Fiscal Year 2022-2023, to the percentage of the portion of health insurance for employee's contribution to health insurance for Fiscal Year 2023-2024. No changes to the vision insurance rates for Fiscal Year 2023-2024. Set May 8, 2023 at 9:15 a.m. as the date and time for a public hearing for an amendment to Hancock County's budget for fiscal year 2022-2023.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried unanimously, the Board gave approval to the following: Signed Wellmark documents: Wellmark rate sheet and Medicare Secondary Payer (MSP) addendum. Approved an increase in dental insurance rates of 5% for Fiscal Year 2023-2024. Approved no change to the employee's contribution to the dental and vision insurance of county paying entire single policy and employee choosing family insurance paying the difference between single and family.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and carried unanimously, the Board authorized the County Auditor to issue checks for the claims on file from April 3 to April 17, 2023 as follows:
